The Stack the Deck performance-based show & sale will be collectively judging bison according to performance based data and management practices of their home ranches.

NBA Executive Director Jim Matheson, Communications Director Karen Connely, and NBA President Chad Kremer are all in attendance. "There is so much to engage with this year for bison. We've got folks raising our national mammal, regenerating healthy soils and grasslands, and demonstrating so much resiliency. We have a lot of hope for what is to come in the markets, in resources for drought and processing needs, and research especially through the Center of Excellence in Bison Studies at South Dakota State," said Jim Matheson.

Whitman Participates in Sustainable Ag DC Summit

Lydia Whitman, Program Manager for the National Bison Association just got back from the National Sustainable Agriculture Council (NSAC) Winter Conference in Washington, D.C. The NSAC Winter Meeting was a chance for members to strategize together around coalition priorities for the year and plans to ensure that the next farm bill invests in resilient local and regional food systems, and levels the playing field for small- and medium-sized farms and farm-related businesses.

This meeting included in person remarks by United States Secretary of Agriculture, Thomas J. Vilsack, who detailed USDA's vision and efforts under the to create



an economy where the wealth and opportunities created in rural America stay there and where a transformed food system helps create new and better markets and more resilient farms and ranches. Farmers and advocates came to Washington, DC to advocate for a range of issues including increased support for sustainable agriculture research, local and regional food systems, working lands conservation, and improving crop insurance.

Lydia met with 14 senate offices, 1 house office, and the house ag committee staff to discuss legislation critical to the bison industry. She was joined for several meetings by Practical Farmers of Iowa Director Sally Worley, and current chair for NSAC's board (pictured above with Whitman). "We can find strength in our alignment with other ag groups as we move forward on farm bill development," says Whitman.

Truth in Buffalo Labeling Bill Introduced in the Senate

Thursday, February 2nd, Senator Hoeven introduced a bil to provide clarification regarding the common or usual name for bison and compliance with section 403 of the Federal Food, Drug, and Cosmetic Act, and for other purposes. Cosigner support was bipartisan and included Senators Bennet (CO), Cramer (ND), Tester (MT), Braun (IN), Smith (MN), Rosen (NV), Thune (SD), Moran (KS), and Marshall (KS).

The truthful labeling of bison products represents more than simply a labeling issue. The choice to use bison meat for human or pet consumption is because of nutritional factors, dietary consideration, or simply because federal regulations prohibit the use of growth hormones in bison. Thus, the deceptive labeling of bison products compromises those consumers' right to make an informed choice. American bison ranchers established a relationship with our customers that is based upon the quality of our meat, and the manner in which we raise our bison. Mislabeled water buffalo products in the marketplace threaten to undermine this relationship.

The bill was read twice and referred to the Committee on Health, Education, Labor and Pensions. We will continue to track progress in the weeks to come.

JEMEZ PUEBLO, NM (January 24, 2023)--A Memorandum of Understanding (MOU) formalized last week between the National Bison Association and the New Mexico-based Flower Hill Institute will expand efforts to assure that bison ranchers and processors have full access to the resources USDA is offering to create a more resilient, diverse and equitable meat processing system.

The MOU signed between the two organizations last week formalizes a commitment to develop and expand the processing resources available to the bison business. Last year, the USDA announced a commitment of \$1 billion in loans, grants, and other resources to create a more resilient, diverse, and equitable meat and poultry processing system in the United States. As part of the commitment, USDA established a network of organizations to provide technical assistance to ranchers and farmers seeking to access those resources. Flower Hill Institute, an Indigenous-led nonprofit organization, entered into a cooperative agreement with USDA Agricultural Marketing Service to coordinate the technical assistance network.


Flower Hill has also developed a series of MOUs with organizations to extend the reach of the technical assistance network.

National Bison Association President Chad Kremer noted, "We have a great group of processors in our business who are looking to expand their operation, and several new projects emerging around the country. We are pleased to partner with Flower Hill Institute to make sure our members have full access to the resources that USDA is offering to support the growth of our processing sector."

Roger Fragua, executive director of Flower Hill Institute, added, "Independent ranchers and Tribal producers are playing a vital role in restoring this magnificent animal to its historic habitat. We are pleased to work with the National Bison Association to make sure that the processing capacity expands to be able to bring this healthy, natural meat to more people across the country."

Kansas bison producer Dick Gehring was recently honored as the National Bison Association's (NBA) 2022 Member of the Year.

Awarded each year during the association's Winter Conference, the Member of the Year is presented to a member who goes above and beyond. In the months leading up to the award, the NBA Past Presidents' Council receives member of the year nominations from fellow NBA members and then votes on the recipient.

Gehring, who operates Black Kettle Buffalo near Moundridge, KS, is a long-time member, current Chair of the NBA Commercial Marketers Committee, and past president of the NBA. Nominees noted his commitment to the organization through service on the Board of Directors as well as numerous committee and his work with the Gold Trophy Show and sale. On the home front, Gehring has been involved with the Kansas Buffalo Association (KBA) for many years and spearheads the group's annual auction each December. He also does consulting and is always available to answer questions and lend his support to producers both new and established. One nominee noted his strong work ethic and his mentorship, noting they could only hope to have Gehring's grit and determination.

Gehring's tireless dedication to all things bison garnered him accolades from many in the bison community. As part of his service to the NBA, Gehring still serves on the Past Presidents' Council, making the voting on nominations a little tricky for the rest of the group. Past Presidents' Council Chair, Gail Griffin, who did the honors of presenting the award, noted that there was some evasive maneuvering done to keep Gehring in the dark about being this year's recipient.

Gehring received the award during the association's annual fundraiser dinner, in which 500 of his friends and colleagues in the bison community celebrated the recognition. The group went on to raise nearly \$70,000 that evening for the NBA and its partner foundations, the National Buffalo Foundation and the Throlson American Bison Foundation.

Ask the Expert: A Q&A on Agricultural Wetlands and Water Quality with Dr. Joseph Prenger

Dr. Joseph (Joe) Prenger is the Wetlands Lead for the Conservation Effects Assessment Project (CEAP), an effort led by USDA's Natural Resources Conservation Service (NRCS) to quantify the effects of voluntary conservation across the nation's working lands. In this Ask the Expert, Dr. Prenger answers questions about new CEAP findings on the capacity of wetlands to capture and store nutrients from cropland fields, associated water quality benefits, and NRCS resources to support wetlands on private and Tribal lands.

Let's start with the basics: What are wetlands, and how do they improve local water quality?

Wetlands occur where water covers or is present near the soil's surface, either seasonally

or year-round. Wetlands in agricultural settings may capture and store sediment and nutrients from the surrounding environment, reduce flooding, contribute to climate change mitigation by serving as a carbon sink, increase biodiversity, and provide wildlife habitat.

This nutrient capture and storage component is key for local water quality. We know nutrients, namely nitrogen and phosphorus, support healthy, productive crops. When nutrients are lost from cropland fields and enter local waterbodies, however, they may contribute to harmful algal blooms and hypoxic or low oxygen zones, and compromise water quality.

A <u>recent CEAP report</u> highlighted an <u>increase in both nitrogen and phosphorus lost from cropland fields</u> over a ten-year period. Based on these findings, <u>NRCS is focusing on efforts</u> to help farmers and other land managers save money and protect water quality with <u>SMART Nutrient Management</u>.

Supporting farmers in making targeted, site-specific decisions to effectively manage nutrients is critical. It's very difficult to achieve 100% crop uptake and 0% nutrient loss, though, even with strong planning. We need SMART Nutrient Management to reduce the amount of nutrients lost from cropland fields, plus a way to capture and store those nutrients that are lost before they reach local waterbodies. Wetlands in agricultural landscapes have the potential to serve this second function, particularly when restored or constructed with this goal in mind.

USDA Issues Additional Pandemic Assistance Payments for Underserved Producers

From FSA National Outreach and Education Update February 2023

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) is currently making automatic Coronavirus Food Assistance Program 2 (CFAP 2) top-up payments to underserved farmers and ranchers. Payments will be based on the 2020 program

certification on form CCC-860, Socially Disadvantaged, Limited Resource, Beginning and Veteran Farmer or Rancher Certification.

Producers who have not previously certified to their status for the 2020 program year have until Feb. 10, 2023, to submit form CCC-860 to be eligible for the additional payments. Contact your local <u>USDA Service Center</u> for more information.

USDA launches cattle-sales database to help producers negotiate Meatingplace

The USDA launched a public database disclosing payment terms for private cattle sales, information that should help producers negotiate more favorable terms, the agency announced Tuesday.

Intended to increase market transparency for cattle producers, the USDA?s pilot Cattle Contracts Library sheds light on the terms, conditions and volumes under which cattle are contracted, the USDA stated in a news release.

"USDA is committed to creating a more level playing field for cattle producers," Agriculture Secretary Tom Vilsack stated. "The Cattle Contracts Library pilot program supports this commitment by providing producers with the market information they need."
