

AMS Follow-Up Meetings and Monthly Price Report

Staff from NBA, and Commercial Marketers Committee Chair, Dick Gehring met earlier this week with staff from AMS- the Agricultural Marketing Service branch of the United States Department of Agriculture.

The meeting was coordinated as a follow-up for topics presented during the Washington D.C. NBA delegation meetings in September. The group discussed how AMS can potentially alter their specifications for purchases for food assistance programs, etc. to better accommodate the bison species in terms of meat testing, packaging, transport schedules, etc. AMS promised to continue to work with the bison industry, as it's proven to be popular among their protein offerings, according to officials from Food, Nutrition Services (FNS).

Gehring and NBA Executive Director, Jim Matheson, had a separate meeting with the AMS Reporting Service regarding the monthly bison meat report. The meeting focused on how the NBA can assist AMS in improving the efficacy of the report while increasing

participation. The group also discussed the potential to have two separate price reports - a commercial and direct-to-consumer, for example, which AMS said was a possibility and would report back with feasibility. AMS also said it was possible to remove the poundage reported to improve the anonymity of participants reporting data.

Said Matheson, "These follow-up meetings are about as important as the initial meetings we had in Washington last month, as it keeps bison top of mind among these decision-makers and allows us to continue to lobby for bison-friendly regulations and policy. It's also encouraging to see that AMS and other agencies at USDA are willing to entertain tailoring policy for bison producers."

Armin Theodore Mueller, was born July 21, 1954 in Ligschwil, Switzerland, the 4th child of 6, to Frieda and Xavier Mueller. Protecting bison is critical to Native American ecosystem, culture From CBS 6 News

Bison were once near extinction. Now, they're coming back. Sometimes called buffalo, these massive animals were an integral part of Lakota, Shoshone and Arapaho culture — to name just a few.

The North American bison is an important animal for many plainstribes in the United States, and tribes like the Cherokee Nation in Oklahoma play a part in that recovery, says Trent Holland, who works for Cherokee Nation's Natural Resources Department.

"A lot of the elders just think there's a connection with all the animals, whether it be a deer, bison, rabbit," Holland said. "There's just lots of spiritual and cultural significance."

Cherokee Nation has grown its herd to almost 220. They've been raising bison since 2014, when they received a grant from the Intertribal Buffalo Council based in South Dakota.

"We received 40 cows from the Badlands National Park and eight bulls from the Teddy Roosevelt National Park," Holland said.

Supreme Court looks for lasting definition of 'adjacent wetlands'

The Supreme Court seems to be searching for a middle ground on the long-standing question of which wetlands should be protected under the Clean Water Act.

During arguments that kicked off the court's October term Monday, neither Acting Solicitor General Brian Fletcher — representing the federal government — nor Pacific Legal Foundation attorney Damien Schiff — arguing on behalf of Idaho landowners

Chantell and Michael Sackett — escaped difficult questions from the justices. But the skeptical questioning of Schiff, in particular, revealed the court was not willing to go as far as he and his clients want — a test that would require a continuous surface water connection between wetlands and "navigable waters" to confer regulatory jurisdiction.

What his clients are looking for, Schiff told the court, is a test that would allow a wetland to be regulated under the CWA "only to the extent that it blends into and thus becomes indistinguishable from an abutting water."

Fletcher, on the other hand, defended the "significant nexus" test developed by Justice Anthony Kennedy for the court's Rapanos decision in 2006, and incorporated into new regulations that have been proposed by EPA and the Army Corps of Engineers:

"[W]etlands possess the requisite nexus, and thus come within the statutory phrase 'navigable waters,' if the wetlands either alone or in combination with similarly situated lands in the region, significantly affect the chemical, physical, and biological integrity of other waters more readily understood as 'navigable.""

But the court is unlikely to adopt either position wholesale, said environmental attorney Duke McCall of Morgan Lewis in Washington, D.C.

Ill. launches state grant program for smaller meat processors From Meatingplace.com

The State of Illinois has established a \$6-million capital grant program that aims to ultimately strengthen the region's meat and poultry supply chain.

Independently owned meat processing companies are eligible to apply for grants that will range from \$250,000 to \$1.5 million, Gov. J.B. Pritzker and the Illinois Department of Commerce and Economic Opportunity said in a statement. The program is designed to include a company match of at least four times the amount awarded to successful applicants.

"By building capacity in the meat processing industry in Illinois, we are strengthening the supply chain, creating and retaining jobs and working to lower costs for families, Gov. Pritzker said.

<u>The Meat and Poultry Supply Chain Capital Grant Program</u> is expected to allow processors to invest in new facilities, expanding or renovating existing facilities or modernizing processing and manufacturing equipment. Program managers plan to focus on meeting the needs of applicants in underserved or rural areas, the announcement added.

The state plans a <u>webinar on the program and the application process</u> on October 11 at 2 PM Central time.

JBS shuttering plant-based Planterra business From Meatingplace.com

JBS USA is shutting down its plant-based business Planterra, according to a report from the Denver Business Journal.

The closure will affect 121 workers in the Denver area. Workers at Planterra's Lafayette HQ were sent home midweek, and JBS will shut down the recently built Planterra manufacturing plant in Denver by mid-December.

On Friday, Planterra filed a shutdown notice with the Colorado Department of Labor and Employment. JBS will help workers find jobs elsewhere in the company, and is also offering severance/unemployment benefit access.

Planterra launched in 2019, and produced the Ozo line of plant-based burgers, cutlets, and ground products. Its CEO was Darcy Macken, who previously worked with Noosa yogurt.

In a statement to Meatingplace, JBS USA's Nikki Richardson said: "We continue to believe in the potential of plant-based options for consumers and remain committed to the alternative protein market. JBS will focus its efforts on its plant-based operations in Brazil and Europe, which continue to gain market share and expand their respective customer bases."

Meat workers among those to get \$600 relief payments From Meatingplace.com

USDA announced Tuesday that 14 nonprofit organizations and the Cherokee Nation were selected to distribute about \$655 million in pandemic relief grant payments of \$600 each to farm and meatpacking workers and front-line grocery workers.

The funding program, initially announced last year, is intended to help workers who incurred health and safety costs related to the COVID-19 to defray expenses for personal protective equipment, dependent care and expenses associated with quarantines and testing.

The organizations are now preparing systems and will begin implementing outreach so that eligible workers may apply to these grant recipients to receive the payments, the agency said. USDA anticipates that beneficiaries will be able to apply for funds from some of these recipients as soon as late November. Workers must provide valid proof of ID and employment to receive a payment.

The program is administered by USDA's Agricultural Marketing Service. The organizations that will distribute the funding to farm and meatpacking workers <u>can be viewed here</u>.

Virtual Workshops Highlight Improvements to Whole-Farm Revenue Protection and Micro Farm From USDA

The U.S. Department of Agriculture (USDA) is offering virtual workshops – on Oct. 11, Oct. 13, Nov. 15, and Dec. 13 – for agricultural producers and stakeholders to learn about the latest updates and improvements to the Whole-Farm Revenue Protection (WFRP) and the Micro Farm insurance options, two of the most comprehensive risk management options available.

These insurance options are especially important to specialty crop, organic, urban, and direct market producers, and this is part of the USDA's Risk Management Agency (RMA) efforts to increase participation in these options and crop insurance overall.

RMA will host these workshops for agricultural producers via Microsoft Teams events:

Livestock Forage Disaster Program (LFP) From USDA

Program Description

The Livestock Forage Disaster Program (LFP) offers payments to eligible livestock producers with eligible livestock. You must also be a producer of grazed forage crop acreage.

The payments help producers with grazing losses suffered on native or improved pastureland due to a qualifying drought. This can be land with eligible permanent or planted grazing cover.

LFP also provides for livestock producers on rangeland managed by a federal agency, if the agency halts grazing on the land due to a qualifying fire.

For grazing losses due to drought, the Farm Service Agency (FSA) will calculate payments equal to 1, 3, 4 or 5 times the LFP monthly payment rate. The payment rate for drought is equal to 60% of the lessor of the monthly feed cost for all covered livestock or the normal carrying capacity of the eligible grazing land.

For grazing losses due to fire on federally managed lands, the payment begins on the first day the permitted livestock are stopped from grazing the eligible rangeland. It ends on the earlier of the last day of the federal lease of the eligible livestock producer or 180 days from the first day the livestock were stopped from grazing.

The payment rate is 50% of the monthly feed cost for the number of days the producer is stopped from grazing the federally managed rangeland because of a qualifying fire, not to exceed 180 days.

Application Process

You must apply for payment and submit required supporting documents to your local FSA office within 30 days after the end of calendar year the grazing loss occurred.

There is a payment limitation of \$125,000 per program year per person or legal entity. If you have an average AGI of more than \$900,000 that applies, you are not eligible for LPF payments. Legal entities exclude joint ventures and general partnerships. Other terms and conditions may apply.

USDA Assists Farmers, Ranchers, and Communities Affected by Hurricane Fiona

Agriculture Secretary Tom Vilsack has directed the U.S. Department of Agriculture (USDA) to aid recovery efforts for farmers, ranchers and residents affected by Hurricane Fiona. USDA staff in offices across the country are ready to respond with a variety of program flexibilities and other assistance to producers and communities in need....

Disaster assistance for agricultural operations:

USDA offers a full suite of disaster assistance programs to help producers recover after disasters.

Livestock and perennial crop producers often have limited risk management options

available, but there are several disaster programs for them. Key programs offered by USDA's Farm Service Agency (FSA) include:

- The <u>Livestock Indemnity Program</u> and the <u>Emergency Assistance for Livestock</u>,
 <u>Honeybee and Farm-raised Fish Program</u> reimburses producers for a portion of the
 value of livestock, poultry and other animals that were killed or severely injured by
 a natural disaster or loss of feed and grazing acres.
- The <u>Noninsured Crop Disaster Assistance Program (NAP)</u> is available through the local Farm Service Agency. This risk protection includes crop production loss and tree loss for certain, eligible crops. Producers who suffer losses and are signed up for NAP are asked to report crop damage to their local FSA office, respectively, within 72 hours of discovering damage and follow up in writing within 15 days.
- The <u>Tree Assistance Program</u> provides cost share assistance to rehabilitate or replant orchards and vineyards when storms kill or damage the trees, vines or bushes. NAP or Federal Crop Insurance often only covers the crop and not the plant.
- The <u>Emergency Conservation Program</u> and <u>Emergency Forest Restoration</u>
 <u>Program</u> can assist landowners and forest stewards with financial and technical assistance to restore damaged farmland or forests.

It is also critical that producers keep accurate records to document damage or loss and to report losses to their local USDA Service Center as soon as possible.

Additionally, USDA's Natural Resources Conservation Service (NRCS) can provide financial resources through its Environmental Quality Incentives Program to help with immediate needs and long-term support to help recover from natural disasters and conserve water resources. USDA can also assist local government sponsors with the cost of recovery efforts like debris removal and streambank stabilization to address natural resource concerns and hazards through the Emergency Watershed Protection Program.

On farmers.gov, the <u>Disaster Assistance Discovery Tool</u>, <u>Disaster-at-a-Glance fact sheet</u> (PDF, 1.4 MB) and <u>Farm Loan Discovery Tool</u> can help producers and landowners determine program or loan options. For assistance with a crop insurance claim, producers and landowners should contact their <u>crop insurance agent</u>. For FSA and NRCS programs, they should contact their local <u>USDA Service Center</u>.

USDA's Food and Nutrition Service (FNS) is already providing assistance to those communities affected in Puerto Rico through household distribution of USDA Foods, which provides nutritious, high-quality foods 100% grown and produced on farms in the U.S. FNS is standing by to work with the Federal Emergency Management Agency (FEMA), states and local authorities, to provide additional emergency nutrition assistance to people in need.

Western SARE Professional + Producer Grant

Proposals are due November 3, 2022.

Western Sustainable Agriculture Research and Education (SARE) is accepting proposals for its Professional + Producer Grant. This program involves an agricultural technical advisor (main applicant) and collaboration of at least three producers in implementing projects to address identified needs in sustainable agriculture.

Projects must integrate research and education aiming to advance the three components of sustainable agriculture- environmental, economic, and social- and use innovative educational outreach to disseminate new knowledge to producers and other agricultural stakeholders.

The maximum grant is \$75,000 over a one- to three-year time period.

Farmer Grant Program - SARE Northeast

Northeast SARE offers grants to farmers to explore new concepts in sustainable agriculture conducted through experiments, surveys, prototypes, on-farm demonstrations or other research and education techniques. Farmer Grant projects address issues that affect farming with long-term sustainability in mind.

Competitive proposals explore new ideas and techniques or apply known ideas in new ways or with new communities. Reviewers look to fund projects that are well-designed to meet proposed objectives and promise the greatest benefit to farming communities.

A wide variety of topics can be funded by Northeast SARE, including marketing and business, crop production, raising livestock, aquaculture, social sustainability, climatesmart agriculture practices, urban and Indigenous agriculture and much more. For guidance on how to design your project, refer to SARE's bulletin, <u>How to Conduct Research on Your Farm or Ranch</u>. Eligible Applicants

The Farmer Grant program is open to all commercial farm business owners and farm employees in the Northeast region. This grant program accepts all types and scales of farms - large or small scale, organic or conventional, urban or rural, full- or part-time, etc. To be eligible, you must meet the U.S. Census of Agriculture definition of a Farm: "Any place from which \$1,000 or more of agricultural products were produced and sold, or normally would have been sold, during the census year." Minnesota AGRI Livestock Investment Grant

Applications are due by November 15, 2022.

The AGRI Livestock Investment Grant encourages long-term industry development for Minnesota livestock farmers and ranchers by helping them improve, update, and modernize their livestock operation infrastructure and equipment.

Minnesota farmers raising beef cattle, dairy cattle, swine, poultry, goats, mules, bison, sheep, horses, farmed Cervidae (deer), Ratitae (flightless birds including emu), and llamas may apply for reimbursement of 10% of the first \$250,000 of an eligible investment.
